3. HAZARDS IDENTIFICATION

PRIMARY ROUTES OF ENTRY: Inhalation, Ingestion, Skin, Eyes
EFFECTS OF OVEREXPOSURE:

INHALATION: Headache, dizziness, nausea, and loss of coordination are indications of excessive exposure to vapors or spray mists. May cause nervous system depression. Extreme overexposure may result in unconsciousness and possibly death. Overexposure to Methylene Chloride can raise the level of carbon monoxide in the blood. Cardiovascular problems may be aggravated by overexposure to Methylene Chloride.

INGESTION: Vomiting. Aspiration hazard if swallowed.

SKIN CONTACT: Irritation. Redness and itching or burning sensation may indicate excessive skin exposure.

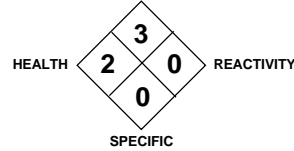
EYE CONTACT: Irritation. Redness and itching or burning sensation may indicate eye exposure.

MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE: None generally recognized.

CHRONIC HEALTH HAZARDS: Methylene Chloride is listed by IARC and NTP. Laboratory animals exposed to high levels of Methylene Chloride in lifetime studies have developed cancer. There is no evidence to date that Methylene Chloride causes cancer in humans. Prolonged overexposure to solvent ingredients in Section II may cause adverse effects to the liver, urinary and cardiovascular systems. Reports have associated repeated and prolonged overexposure to solvents with permanent brain and nervous system damage.

4. FIRST AID MEASURES

EMERGENCY FIRST AID PROCEDURES:

INHALATION: If affected, remove from exposure. Restore breathing. Keep warm and quiet.

INGESTION: Never give anything by mouth to an unconscious person. Give conscious patient several glasses of water. If vomiting is not spontaneous, induce vomiting by having the patient gently touch the back of his throat with a finger. Keep airway clear. Seek medical attention.

SKIN CONTACT: Wash affected area thoroughly with soap and water. Remove contaminated clothing and launder before re-use.

EYE CONTACT: Flush eyes with large amounts of water for 15 minutes. Get medical attention.

5. FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA: Carbon dioxide, dry chemical, foam.

FIRE FIGHTING PROCEDURES: Full protective equipment including self-contained breathing apparatus should be used. Water spray may be ineffective. If water is used, fog nozzles are preferable. Water may be used to cool closed containers to prevent pressure build-up and possible autoignition or explosion when exposed to extreme heat.

UNUSUAL AND EXPLOSION HAZARDS: Isolate from heat, electrical equipment, sparks and open flame. Closed containers may explode when exposed to extreme heat. Application to hot surfaces requires special precautions. During emergency conditions overexposure to decomposition products may cause a health hazard. Symptoms may not be immediately apparent. Obtain medical attention.

6. ACCIDENTAL RELEASE MEASURES

SPILLS OR LEAKS: Remove all sources of ignition. Ventilate and remove with inert absorbent.

7. HANDLING AND STORAGE

SPECIAL PRECAUTIONS: Keep away from heat, sparks or open flame. Vapors will accumulate readily and may ignite explosively. During use and until all vapors are gone: Keep area ventilated – Do not smoke – Extinguish all flames, pilot lights and heaters – Turn off stoves, electric tools and appliances, and any other sources of ignition. Consult NFPA Code. Use approved Bonding and Grounding procedures. Contents under pressure. Do not puncture, incinerate, or expose to temperatures above 120°F. Heat from sunlight, radiators, stoves, hot water, and other heat sources could cause container to burst. Do not take internally. Keep out of the reach of children. Intentional misuse by deliberately concentrating and inhaling the contents can be harmful or fatal.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

PRECAUTIONS TO BE TAKEN: Use only with adequate ventilation. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Wash hands after using. This coating may contain materials classified as nuisance particulates (listed "as Dust" in Section II) which may be present at hazardous levels only during sanding or abrading of the dried film. If no specific dusts are listed in Section II, the applicable limits for nuisance dusts are ACGIH TLV 10mg/m³ (total dust), 3mg/m³ (respirable fraction), OSHA PEL 15mg/m³ (total dust), 5mg/m³ (respirable fraction).

RESPIRATORY: If personal exposure cannot be controlled below applicable limits by ventilation, wear a properly fitted organic vapor/particulate respirator approved by NIOSH/MSHA for protection against materials in Section II. When sanding or abrading the dried film, wear a dust/mist respirator approved by NIOSH/MSHA for dust which may be generated from this product, underlying paint, or the abrasive.

SKIN PROTECTION: None required for normal application of aerosol products where minimal skin contact is expected. For long or repeated contact, wear chemical resistant gloves.

EYE PROTECTION: Wear safety spectacles with unperforated sideshields.
